1212 Minutes of the meeting held 27^h May 2025 (previously circulated) and Matters arising. The minutes had been circulated in advance of the Meeting. It was agreed that there were no matters arising that were not covered elsewhere on the agenda.

1213 Clerks Report Financial Statement

The Clerk reported that 8 cheques had been raised in the period May to June 2025

There was £704.44 VAT outstanding at the end of June 2025 which has not been claimed.

Taking the above into account, the expected bank balance is £23,477.56 which is reconciled to Bank statement at the 30th June 2025. This balance contains the remaining reserves of £2857.50 for Orchard Piece Community Play Area. The General Fund at the end of June stands at £20,677.30.

The Clerk reported that a completed re-declaration of compliance for Mollington Parish Council had been sent and received by The Pensions Regulator under the Pensions Act 2008, the Notification of Public Rights period had been completed and Certificate of Exemption for the AGAR 2024/25 had been submitted before the deadline of the 30th June.

1214 Consultations

The Parish Liaison meeting was held at CDC's new offices in Castle Quay on the 11th June. It was reported that there is to be a Local Government reorganisation, decided by the Government. No timescale has been published, but CDC have been invited to submit their proposals in November. The first wave of change is likely to be in 2027, with CDC likely in 2028.

Engagement with Town and Parish Councils to get views on the proposals will be held during the summer (dates on CDC website).

The change is to create one local authority for regions that delivers all of the services at county and district level – restructuring two tiers into one unitary council.

CDC proposes the creation of 2 unitary councils – Cherwell, Oxford and W Oxford, and the Vale of the White Horse and West Berks. In contract, OCC prefers one, and Oxford City would propose 3. They need to put forward compelling and persuasive bid that will benefit residents and identify the opportunities it would bring. Key benefits of their proposal are that the regions would be the right size, and of equal economic footprints and there would be minimal disaggregation.

Although ultimately, the Government are looking to reduce the number of councillors, part of the proposal needs to keep the link between Councillors and localities.

Devolution is still on track, where the passing of the powers and funding moves from central Government to regional councils., where the mayoral strategic authority would provide a more direct link route for local representatives in Whitehall. The Devolution timeline remains unclear.

The appeal follows non-determination of a Planning Application at Point to Point House for a Certificate of Lawfulness of Existing Use to regularise the existing use of a dwelling house.

There have also been enforcement notices served at the same address regarding the lack of planning permission for the change of use for land and buildings from agricultural to leisure (indoor riding school) and business use (Pilates and chiropractic studios). An invitation to comment will be issued once the dates of any appeals are published.

Received quote for removal works of old slide / spring rocking horse in Orchard Piece Playing Field, this was unanimously approved and accepted by the Councillors.

Tree damage on Roundhill Rd required assistance from Tony Best (PC thanks him for his support here) on removal, requested through FixMyStreet for removal of debris by Highways / CDC Awaiting details of scheduled works by Highways for pot holes and water drainage issues on March Hill. Several emails have been issued to Highways. To date some marking up of potholes has taken place.

Village Hall

Mollington Munch celebrated its 10th anniversary with a summer buffet this was well attended (40+) Coffee mornings continue to take place.

Planned events include games and social night (2 Aug), boot sale (25 Aug), 70/80 Cocktail with disco (20 Sept), History of Mollington (18 Oct), Quiz Night (29th Nov) and Christmas Fayre (6 Dec) which will be advertised by posters throughout the village as well as on their Facebook page.
